
2025 REGISTERS

The Board maintains separate registers for Veterinary Surgeons and Veterinary Paraprofessionals, as stipulated in the Veterinary Surgeons and Veterinary Paraprofessionals (VSVP) Act of 2011. These registers serve as official records of licensed professionals within the veterinary sector in Kenya.

For a person to be considered registered, their name must appear in the relevant register. If a person's name is absent, they are deemed not to be registered.

In the 2025 register, a total of 4,781 practitioners have been listed. This reflects the ongoing efforts of KVB to ensure that only qualified and authorized professionals are practicing in the veterinary industry, thus safeguarding animal welfare and public health in Kenya.

INSPECTION ACTIVITIES

KVB shall enforce the set veterinary standards and practices as outlined in the VSVP Act 2011 through conducting inspections of veterinary service providers and ensuring compliance with the regulatory requirements provided.

The Board strives to optimize enforcement and compliance to the set veterinary standards. This entails inspection and licensing of animal health service providers. The Board closely works with other government organizations such as Veterinary Medicines Directorate (VMD) to inspect the veterinary service providers, this will help the Board to improve the quality of veterinary services in the country.

The Board has planned inspections countrywide to enhance compliance.
